FUNDAMENTAL REPRESENTATION AND UNDERTAKING

I represent that I come to the Team having pursued my athletic goals in a spirit of Fair Play and respect for myself and my opponents, on and off the field of play, and I promise to continue to act and compete in that spirit of Fair Play throughout the period of this Agreement and beyond.

All members of the Team, be they mission staff, team leaders, coaches, other team support personnel, or athletes, are expected to have through their behavior embraced the philosophy of Fair Play and to conduct themselves accordingly during the event.

I therefore represent, as an athlete member of the Team that I have not engaged in and promise that I will not engage in, conduct that is inconsistent with the philosophy of Fair Play; that is, respect for the dignity of all men and women both individually and collectively, with proper regard for the harmonious development of all persons, including myself, towards the goal of achieving the best that one can be in body, will, and mind.

I represent that if I have engaged in conduct inconsistent with the above stated philosophy of Fair Play I have made such known to the BC Archery Association prior to my selection to the Team and I have served any suspension or other discipline and I am entitled to participate and compete in my sport nationally.

Athlete Benefits

Once I have arrived at the location of the event, my travel to and from the event will be arranged by the Team Leader. A team uniform will be provide to me for the event .Funding for my travel will be given to me when I arrive at the event; the amount is to be determined depending on team size and location.

Athlete Obligations

I agree to conduct myself at all times in a manner becoming a member of the Team and specifically to conduct myself in an appropriate manner so as to not bring myself, the BC Archery Association or the Team into public disrepute or censure.

Doping

Doping is prohibited. In order to avoid any inadvertent doping offences, I will be asked to disclose and show the packaging of all medications and over-the-counter vitamins and nutritional supplements that I have taken in the 7 days prior to my arrival at the event and during the event as required. *Dope testing is normal at the Event and when asked to test, I will comply.*

Media

The Team Leader is the official spokesperson for the Team. I agree not to make comments to the media that would negatively affect the Team in anyway.

Breach of Agreement

If I breach any part of the Agreement, (which includes good conduct clauses), or have misrepresented anything I say in the Agreement, I may be disciplined. In such instance, a Team Conduct Review Committee will be convened and the Team Leader will take such disciplinary action determined appropriate by the Team Conduct Review Committee.

Release and Assumption of Risk

By signing the Agreement, I release the BC Archery Association from claims for damages, and acknowledge and assume the risks that go with my participation in the Event.

I, for myself, and on behalf of my heirs, executors, administrators and assigns, and next of kin, agree not to sue and hereby release the BC Archery Association, its officers and directors, employees, volunteers, coaches, officials, servants, agents and other members of the Team, from and in respect of any claims, demands, damages, actions or causes of action arising out of or in consequence of any loss, injury, or damage to my person or property incurred while participating in or training for any event at the Games or while traveling to or from the Games or while at the Games.

I acknowledge, appreciate, and agree that I risk bodily injury, including paralysis, dismemberment, and death, arising from my training for or participation in the Games. While particular rules of my sport, equipment, and personal training and discipline may reduce this risk; this risk of injury does exist. I knowingly and freely assume all these risks, both known and unknown.
